- Your employer's name;
- Your social security number;
- Your home address and zip;
- Your citizenship status;
- Marriage status;
- Number of dependents under the age of 26;
- Your household income;
- If you currently have or have access to other coverage through other means (Such as Employer Coverage, Medicare, Medicaid, CHIP, ARKids First, TRICARE, Department of Veterans Affairs or Peace Corps);
- The cost of the coverage you currently have (You can get that through your employer or the insurance company you purchased the coverage from.)
